# III. Consent Agenda

Upon a motion made by Mr. Thompson and seconded by Ms. Jackson, the Consent Agenda, consisting of the Agenda and Minutes of August 26, 2021, was approved without objection. - a. <u>SR/VPK Fiscal Year Benchmark Report, Enrollment/Wait List Status Report, and Contracting Summary Report</u>
- 1. SR/VPK Fiscal Year Benchmark Report:

The benchmark report and associated financials were not available for review.

## 2. Enrollment/Wait List Status Report:

Nearly 3,000 children are enrolled in the School Readiness Program. The Coalition has slowed pulling from Wait List each week because the number of parents who cannot find a child care provider for their children has resulted in over thirty children authorized, but not enrolled. Future pulls will be dependent upon the number of children waiting for a provider.

# VI. Old Business

## a. DEL CRRSA and ARPA Grants

The DEL has started the process to get approval for CRRSA Phase VI. Planning is already in work for the use of the ARPA grants coming in 2022.

#### b. Coalition Relocation Update

The work to remodel the new Coalition offices continues but has experienced delays. The move is now scheduled for December.

# 1. Financial Review, Feb-Apr 2021

The Financial Review process is still ongoing. The Coalition has submitted a Proposed Corrective Action Plan (PCAP) for the 11 findings in the report.

#### d. Time Reporting and Compensation Policy Workgroup Schedule

The DEL still has not published their new guidance on time reporting and compensation. The new Chancellor is looking at policy guidance. Therefore, the Committee decided the workgroup should meet to review related Coalition policy and recommend changes as required. At least three meetings will be scheduled once the availability of members is determined, and a schedule developed and properly noticed as required by Sunshine.

### VII. New Business

## a. <u>Board Member Resignation</u>

On October 15, 2021, Drew Hardgrave submitted his resignation from the Board. This now leaves two of three Governor appointed positions vacant. There is one application submitted that has not been acted upon. Efforts will begin to recruit another applicant for Governor appointment. Mr. Hardgrave has served the Coalition well and his support will be missed.

#### b. <u>DOH Board Designee Change</u>

The Department of Health has notified the Coalition that their current designee, Ms. Beate Bolton, is retiring. They have designated Ms. Deborah Tucker to be their designee. Upon a motion made by Mr. Thompson and seconded by Ms. Jackson, the Committee's recommendation to the Board to approve the appointment of Ms. Tucker was approved without objection.

#### c. 2022 Board and Committees Schedule

The Executive Director, Mr. Bruce Watson, submitted his resignation for September 23, 2022. He wanted to notify the Coalition well ahead of his departure date so that the Board had sufficient time to identify a new Executive Director and there would be adequate time for a proper turnover.
